- As per G.O.Ms.No.85, HM&FW (C1) Dept., dt.20-07-2024, the Govt. of A.P has dispensed with In-Service quota in PG Dental Courses from the academic year 2024-25.
- As per G.O.Ms.No.86, HM&FW (C1) Dept., dt.20-07-2024, the Govt. of A.P. issued orders to de-notify Government Dental College & Hospital, Vijayawada as a state wide Institution and reclassify it as a Non-Statewide Institution from the academic year 2024-25 and to fall under the jurisdiction of Andhra University (AU).
- As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 of Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.
