PG (DENTAL) SPECIAL STRAY VACANCY ROUND UNDER MANAGEMENT QUOTA SEATS AFTER LOWERING OF CUT-OFF SCORE – 2024-25

In continuation to this Office Notification, dt.20-09-2024, Notification for exercising web options for admissions into Post Graduate Dental Degree/Diploma Courses against Special Stray Vacancy Round for the academic year 2024-25 under Management Quota Post Graduate Dental Degree / Diploma courses, in Private Un-aided Non-minority Dental Colleges affiliated to Dr. NTR UHS as per the vacant seats available and placed in the University website on 14-10-2024.

INSTRUCTIONS

- 1. Eligible candidates whose names are in the Final Special Stray Merit Position notified in the University Website on 14-10-2024 are only eligible to exercise web options as per the above dates.
- 2. In respect of S1B seats, preference will be given to local candidates of Andhra Pradesh and if eligible candidates from Andhra Pradesh are not available, the same will be allotted to S1A candidates based on Merit list, options and subject to availability of seats.

3. Eligible candidates:

- a) Eligible candidates who got no seats in Phase/Round-I, II, III and Stray Vacancy round (AIQ, State, Deemed) can participate in Special Stray Vacancy Round.
- b) The candidates who have been allotted, but not joined in Phase/Round I, Phase/Round II of State Quota and All India Quota are eligible to participate in this counselling.

4. Not Eligible Candidates:

- a) The candidates who are holding MDS seat in Phase-I & II of State Counselling are not eligible to participate in Special Stray round of counselling.
- b) Candidates who availed Exit option, vide this University Notification, dt.21-08-2024 are not eligible to participate in Special Stray round of counselling.
- c) A candidate allotted a seat in Phase-III (Mop up) and Stray Vacancy round of State counselling and Stray Vacancy round conducted by MCC/DGHS cannot participate in further rounds of State Counselling.
- d) The candidate who is holding a seat allotted in Round 1, Round 2, Round 3 and Stray Vacancy round in All India Quota/Deemed universities (conducted by MCC/DGHS).

- e) The candidates who have been allotted in Special stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State Special Stray Round of counselling regardless of whether they applied or chose options in that round. Such names will be deleted before processing allotments for Special Stray Vacancy round.
- 5. If a candidate is allotted a seat in Special Stray round, he/she has to **compulsorily** report & join the allotted seat/college else he/she **shall be debarred** from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year. For complete details refer Prospectus placed in the website on 20-07-2024.
- 6. Vacant seats for Special Stray Vacancy round at the end of Stray Vacancy counselling are displayed in the University website. Hence, candidates are encouraged to select courses in which they have genuine interest of joining, thereby allowing other meritorious candidates the opportunity to secure these seats.
- 7. Candidate can download the provisional allotment order on payment of University fee of Rs.49,600/- through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order.
- 8. The University fee once paid shall not be refunded under any circumstances.
- 9. The allotted candidates shall report at the allotted college immediately in view of MCC, New Delhi schedule. Hence, candidates are advised to keep in touch with University website for information on Stray allotments.
- 10. TUITION FEE: The following is the Tuition fee structure for the academic year 2024-25 to be payable for the Management Quota seats in Private Unaided Dental Colleges as per G.O.Rt.No.504, HM & FW (C1) Department, dated 06-08-2024 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.
