**PG (DENTAL) STRAY VACANCY ROUND UNDER MANAGEMENT
QUOTA SEATS – 2024-25**

Notification for exercising web options for admissions into Post Graduate Dental Degree/Diploma Courses against Stray Vacancy Round conducted by Dr. NTR UHS for the academic year 2024-25 in the State of Andhra Pradesh under Management Quota seats, in Private Un-aided Non-minority Dental Colleges affiliated to Dr. NTR UHS.

INSTRUCTIONS

1. Eligible candidates whose names are in the Final Stray Merit Position notified in the University Website on 11-09-2024 are only eligible to exercise web options as per the above dates.
2. In respect of S1B seats, preference will be given to local candidates of Andhra Pradesh and if eligible candidates from Andhra Pradesh are not available, the same will be allotted to S1A candidates based on Merit list, options and subject to availability of seats.
3. **Eligible candidates:**
 - a) Eligible candidates who are not holding a seat or got no seats in Phase/Round-I, II&III (AIQ, State, Deemed) can participate in Stray Vacancy Round.
 - b) The candidates who have been allotted, but not joined in Phase/Round I, Phase/Round II of State Quota and All India Quota are eligible to participate in this counselling.
 - c) A Candidate who has not registered and not choice locked in the Phase 1 or Phase 2 or Phase 3(Mop up) ONLINE COUNSELLING will be permitted to attend Stray Round of ONLINE COUNSELLING.
4. **Not Eligible Candidates:**
 - a) The candidates who are holding MDS seat in Phase-I & II of State Counselling are not eligible to participate in Stray round of counselling.
 - b) Candidates who availed Exit option, vide this University Notification, dt.21-08-2024 are not eligible to participate in Stray round of counselling.
 - c) A candidate allotted a seat in Phase III (Mop up) of State counselling cannot participate in further rounds of State Counselling.
 - d) The candidate who is holding a seat allotted in Round 1 & Round 2 and Round 3 in All India Quota/Deemed universities (conducted by MCC/DGHS).

- e) The candidates who have been allotted in stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State Stray Round of counselling.
- f) The Candidates who have been allotted seats in the CQ Stray Round will not be eligible for the MQ Stray Round, regardless of whether they applied or chose options in that round.
5. If a candidate is allotted a seat in Stray round, he/she has to **compulsorily** report & join the allotted seat/college else he/she **shall be debarred** from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year. For complete details refer Prospectus placed in the website on 20-07-2024.
6. Vacant seats for Stray Vacancy round at the end of Phase-III (Mop Up) counselling was displayed in the University website on 09-09-2024. Hence, the candidates are therefore advised to exercise options for all the seats in all the colleges irrespective of the vacancies as per their priority if they are really interested to join the Seat.
7. Candidate can download the provisional allotment order on payment of University fee of Rs.49,600/- through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order.
8. The allotted candidates shall report at the allotted college immediately in view of MCC, New Delhi schedule. Hence, candidates are advised to keep in touch with University website for information on Stray allotments.
9. The University fee once paid shall not be refunded under any circumstances.
10. **TUITION FEE: The following is the Tuition fee structure for the academic year 2024-25 to be payable for the Management Quota seats in Private Un-aided Dental Colleges as per G.O.Rt.No.504, HM & FW (C1) Department, dated 06-08-2024 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.**
