In continuation to this Office notification, dt.20-07-2024, Dr.YSR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-I counselling for admissions into Management Quota seats of PG Dental Degree/Diploma courses in Private Un-aided Non-minority Colleges for the academic year 2024-25:

**UNIVERSITY FEE:** Selected Candidates have to login and to pay the University fee of ₹.49,600/- for downloading the Allotment Order by using Online payment method (Debit Card/Credit Card/Internet Banking).

**TUITION FEE:** Tuition fee structure for the current academic year 2024-25 will be as decided by the Govt. of Andhra Pradesh, subject to the outcome of W.P.Nos.32975, 33162 & 35090 of 2022.

**Distribution of seats is as detailed below:**

- 1) As per G.O.Ms.No.57, HM&FW (C1) Dept., dated 28-04-2023 (Non-Minority Colleges):
  - a) Management Quota-Subcategory- 1(S1): 25% of the sanctioned intake of seats, course wise, in each institution shall be filled by the candidates in General Merit based on the NEET MDS-2024 ranking.
  - b) Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET MDS-2024.
  - c) Management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each Institution shall be Institutional preference/In- service management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET MDS-2024.
- 2) As per G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023:
  - a) 15% of Subcategory-1 seats only are open to the candidates from all over the Country – S1A
  - b) For the Remaining 85% of Subcategory-1 seats only Local Candidates of Andhra Pradesh i.e., AU/SVU are only eligible – S1B

**Instructions to Candidates:**

1	Seat Matrix is displayed in the University Website <a href="https://drysr.uhsap.in">https://drysr.uhsap.in</a> for information of the students. All the eligible candidates present in the Final Merit list displayed on 29-07-2024 are eligible to opt for Phase-I.
2	As per the year 2023-24 Notifications for Stray/Special Stray rounds of CQ/MQ counsellings, candidates who participated in Stray/Special Stray rounds of CQ/MQ counsellings conducted for the year 2023-24 and allotted seats but not reported/joined are debarred for admissions into CQ/MQ counsellings for the year 2024-25 (List of debarred candidates displayed on the University website).
3	As per G.O.Ms.No.67. dt.21-04-2017, the candidates who have discontinued the course from the academic year 2021-22 irrespective of their admission batch will be debarred for this academic year i.e., 2024-25(List of debarred candidates displayed on the University website).
4	Candidates are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of specialities and colleges available.
5	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are genuinely interested. <b>If they are not interested to join any speciality or college then they are advised not exercise options for the same.</b>
6	The selected candidates have to login and to pay the University fee of ₹.49,600/- for downloading the Allotment Order by using Online payment method (Debit Card/Credit Card/Internet Banking) and report to the Principal of the Allotted College on or before the date specified in the allotment letter. University fee once paid is not refundable under any circumstances.
7	The selected candidates shall produce all the Original certificates, pay the Tuition fee, furnish necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.

8	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.YSR UHS) during subsequent Phases of counselling the tuition fee will be sent to the slided college by the concerned college where the amount is held.
9	Candidates who have reported the allotted seat of Phase-I can opt for free exit as per the schedule which will be notified.
10	<p>Eligibility for Exercising web options in Phase-II Counselling</p> <p>The following candidates are eligible:</p> <p>a) All the candidates who have been allotted a seat in Phase-I and reported.</p> <p>b) All the candidates who have not been allotted any seat in Phase-I counselling.</p> <p>c) All candidates who have been allotted a seat in Phase-I but not reported/not joined at the allotted colleges. <b>However, if a candidate has not joined/reported in the allotted seat of Phase-I then that particular seat shall not be available for that candidate to exercise web options in Phase-II counselling.</b></p> <p>d) The Joined candidates of Phase-I/Phase-II Counselling are eligible for upgradation up to Phase-III (MoP Up) round only.</p>
11	If any candidate joins allotted seat of Phase-I of Competent Authority Quota (CQ) seat in A.P. State can slide to a seat allotted in this Phase-I of Management Quota seat in AP State and in such case, the tuition fee already paid for the CQ will be returned to the candidate by the concerned college.
12	The University fee and other fee once paid shall not be refunded under any circumstances.
