Admissions into Post Graduate Dental Degree/Diploma Courses against Stray Vacancy Round conducted by Dr. NTR UHS for the academic year 2024-25 in the State of Andhra Pradesh under Management Quota Post Graduate Dental Degree / Diploma courses i.e., S1/S2/S3 in Private Un-aided Non-minority Dental Colleges affiliated to Dr. NTR UHS.

Dr.NTR UHS invites Online applications for the vacant seats after the MQ Phase-III (Mop Up) round from the eligible candidates for admission into **Stray Vacancy** seats of Post Graduate Dental Degree / Diploma Courses under Management Quota seats i.e., S1/S2/S3 in PG (Dental) Courses in Private unaided Non-Minority Dental Colleges in the State of Andhra Pradesh for the academic year 2024-25. ## **INSTRUCTIONS**

- 1. Fresh registrations and fresh choice filling will be obtained for Final Stray Vacancy Round. Candidate whose names already present in the MQ Merit list and not holding any seat are also eligible for Stray vacancy **provided they satisfy the eligibility conditions of Stray vacancy round** and hence they need not apply again for Stray vacancy notification.
- In respect of S1B seats, preference will be given to local candidates of Andhra Pradesh and if eligible candidates from Andhra Pradesh are not available, the same will be allotted to S1A candidates based on Merit list, options and subject to availability of seats.
- 3. Candidates registered and present in the Final Merit list but not holding a seat or got no seat in Phase-I, Phase-II & Phase-III(Mop Up) {AIQ/Deemed/State} and willing to participate in the Stray vacancy round can opt to upload relevant documents for S2 (NRI) and S3 (Institutional Quota) without fresh registration.

#### 4. Eligible candidates:

- a) Eligible candidates who are not holding a seat or got no seats in Phase/Round-I, II&III (AIQ, State, Deemed) can participate in Stray Vacancy Round.
- b) The candidates who have been allotted, but not joined in Phase/Round I, Phase/Round II of State Quota and All India Quota are eligible to participate in this counselling.
- c) A Candidate who has not registered and not choice locked in the Phase 1 or Phase 2 or Phase 3(Mop up) ONLINE COUNSELLING will be permitted to attend Stray Round of ONLINE COUNSELLING.

## 5. Not Eligible Candidates:

- a) The candidates who are holding MDS seat in Phase-I & II of State Counselling are not eligible to participate in Stray round of counselling.
- b) A candidate allotted a seat in Phase III (Mop up) of State counselling cannot participate in further rounds of State Counselling.
- c) The candidate who is holding a seat allotted in Round 1 & Round 2 and Round 3 in All India Quota/Deemed universities (conducted by MCC/DGHS).
- d) The candidates who have been allotted in stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State Stray Round of counselling.
- e) The Candidates who have been allotted seats in the CQ Stray Round will not be eligible for the MQ Stray Round, regardless of whether they applied or chose options in that round.
- 6. If a candidate is allotted a seat in Stray round, he/she has to <u>compulsorily</u>report & join the allotted seat/college else he/she <u>shall be debarred</u> from participating A.P. State Counselling for admission to PG Dental Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year.For complete details refer Prospectus placed in the website on 20-07-2024.

Hence, the candidates are advised to take calculated decision before applying under this notification. Fee once paid shall not be refunded under any circumstances.
- 12. The online application can be filled through any **desktop or laptop** only.
- 13.Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET-MDS-2024Rank.
- 14. Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counsellings. No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
- 15. The Candidates are hereby informed that if they have secured admission in Dental colleges of other States, joined the course and if they are involved in blocking of the seats the University will initiate legal action and same will be informed to the DCI, New Delhi.
- 16. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
