In continuation to the Provisional Final Merit List displayed on 30.10.2024, the University hereby notify the 1st phase of web-based counselling for Admission into Post Basic B.Sc. (Nursing) 2 YD Course for the seats available under Competent Authority Quota including Special Category, i.e., PwD in Government colleges and Private Colleges for the academic year 2024-25.

1. University Fee:

₹.5,600/- (Rupees Five thousand Six hundred only). The Selected Candidates have to pay non-refundable University fee through payment gateway using online payment method (Debit Card / Credit Card / Internet Banking) and applicable bank charges for downloading allotment order.

3. All the Eligible Indian Nationals candidates who have got their uploaded copies of certificates verified and whose names are present in the Provisional Final Merit List displayed on 30-10-2024 can exercise their web options as per the seat matrix which will be displayed in the website: <u>https://drntr.uhsap.in</u>

The allotment of seats is as per the following Government Orders:

- a. G.O.P.No.646, Education (w) Department, dated 10.07.1979
- b. G.O.Ms.No.42, Higher Education Department, dated. 18.05.2009.
- c. G.O.Rt.No.550, Higher Education (EC.2) Department dated.30.07.2001
- d. G.O.Rt.No.111, Higher Education (E.C) Department dated.13.08.2019 and
- e. G.O.Rt.No.159, Higher Education (E.C) Department, Dated.13.11.2020.
- 5. All unfilled seats under PwD quota will be converted and added to respective categories, since the seats under special category are Horizontal Reservation.

6. <u>Reporting at the allotted college</u>:

- a) Candidates will receive the message to their registered mobile after allotment of seat, if seat is allotted. The candidates are instructed to visit the Website: <u>https://drntr.uhsap.in</u> for status of allotment after closure of Web Options.
- b) Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee through payment gateway as specified with all Original Certificates and also pay the Tuition Fee, to complete the admission process before the date specified on the allotment letter, failing which the candidate will forfeit the admission.
- c) Verification of Original Certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.

d) If not allotted any seat in Phase-I:

Candidates who have not been allotted any seat in the Phase-I of counselling will be considered for available vacancies in Phase-II of counselling with fresh Options.

e) If not reported at the allotted college :

The candidates who do not report at the allotted college in the Phase-I counselling, will be allowed to participate in the Phase-II counselling with fresh options, provided that the candidates have no right to claim earlier Phase-I allotted seat again under Phase-II counselling.

- f) If the joined candidates of Phase-I slides to other college during Phase-II of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order alongwith Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.
- g) Candidates getting upgraded in Phase-II of Counselling will not have any claim on previous allotments, i.e., Phase-I seat as the vacancies resulting from upgradation are filled within this phase by the next candidate in the merit list with rules of reservation as applicable.
- 7. Candidates are advised to read the regulations and prospectus of Dr. NTR UHS available on Website carefully before exercising web options.
- 8. Candidates can exercise web options through -<u>https://apuhs-ugadmissions.aptonline.in/UGNRTY/Home/StudentLogin</u> from home or any other place having internet facility. Use only system with Internet Explorer versions 11 or above. DO NOT USE TABS OR MOBILES TO EXERCISE WEB OPTIONS.
- **9.** Candidates can exercise options to all colleges to which they are eligible. The allotment of seats will be as per the order of priorities/options given by the candidate.

- **10.** Candidate can exercise Web Options from any place having internet facility. One Time Password will be sent to the registered mobile number at the time of saving Web options.
 - I) Selected Options can be slided either up or down, added and deleted.
 - II) Web options opted must be saved by the candidate.
 - III) Web options once submitted cannot be Edited.
 - IV) Web options saved but not submitted until the cut-off date and time will be Auto submitted.
- 11. Candidates are instructed to take a print out of saved options.
- **12.** Candidates have to check website <u>https://drntr.uhsap.in</u> for allotment of seats after closure of date of exercising options for status of allotment.
- **13.** Candidate has to take print-out of allotment order. Check their allotment and report to the Principal of respective college before the date specified on the allotment letter.
- 14. The selected candidates shall report to the Principal with all original certificates, allotment order and Provisional Verification form, pay the College fee before the last date and time at the allotted college as mentioned in the allotment letter.
- 15. The University Fee once paid shall not be refunded under any circumstances.
- **16.** Next rounds of counseling will be conducted for:
 - A. Left over seats in Phase 1
 - B. Not reported / Not joined seats
 - C. Seats added, if any.
- 17. No individual communication will be sent to the candidates. Candidates are advised to check the university website: <u>https://drntr.uhsap.in</u> from time to time for all further notifications for exercising web-options, list of allotted candidates, Instructions etc.
- **18.** Candidates are advised to refer the Prospectus displayed on Dr. NTRUHS web-site for eligibility criteria and any other details.
