Notification for exercising web options for 1<sup>st</sup> Phase of web-based counseling for admission into **BAMS & BHMS** Courses under **Management Quota** and **All India Quota** Seats in Private Un-aided Non-Minority BAMS & BHMS colleges under Dr. NTR UHS for the academic year 2024-25.

In continuation of earlier notification dated 21.10.2024, the University hereby notifies the **1st Phase** of web-based counselling for **BAMS & BHMS Courses** available under Management Quota and All India Quota seats in Private Un-aided Non-Minority, BHMS/BAMS colleges (under Dr. NTR UHS) for the academic year 2024-25 in the state of Andhra Pradesh.

All the eligible candidates who are present in the Merit list notified in the website on **05.11.2024** only eligible to exercise their options as per the seat matrix displayed on the **website <https://drntr.uhsap.in>**

**Allotment Process:**

- Eligibility criteria for both AIQ & MQ Seats are similar and all seats are in open in nature and there is no requirement for any domicile certificate. The seat allocation will be done as per the directions issued by the Ministry of AYUSH, New Delhi, Lr. No. NCISM/COE/Neet-UG/2024, dt.22-08-2024.**
- AIQ Seats will be filled first in a college based on options by order of merit from the Merit List.**
- Important Note: - NCISM, New Delhi, Ministry of Ayush has notified that, there shall not be any offline admission or admission without counselling (Central/State/UT) and any admissions in contravention of this shall not be approved. Hence, all admissions under Management will be conducted by Dr. NTR UHS, Vijayawada only.**

**UNIVERSITY FEE:** Candidates to whom allotment message is given have to pay **Rs.20,100/-** for **Management Quota** and **Rs.8,600/-** for **All India Quota** before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

**TUITION FEE FOR BAMS & BHMS COURSES:** The selected candidates have to pay tuition fee per year for admission into **MQ & AIQ** seats in Private **BAMS & BHMS** Courses in Un-aided, Non-Minority Ayurvedic & Homoeopathy Colleges as per orders of the following Government of Andhra Pradesh G.Os.

### **Instructions regarding web options and allotment of seat:**

1. Eligible candidates should exercise web options for the available seats in all Private Unaided Non-Minority Ayurvedic & Homoeopathy Medical colleges in the State of A.P. along with application.
2. Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2024-25 notified by AACCC, New Delhi, Vide Ref. No. AA-11013/1/2024-EP-I, dt.02.11.2024 are not eligible to participate under this notification.
3. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of web options schedule.
4. Candidates are instructed to be careful while exercising options on the web.
5. No further notification for exercising web options will be issued.
6. Based on the merit list and order of priority of colleges, allotment letters will be released to the candidates, if seat is allotted.
  - a) Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates are also instructed to visit the [website: https://apuhs-ugadmissions.aptonline.in/UGAYUSHMQ/Home/studentlogin](https://apuhs-ugadmissions.aptonline.in/UGAYUSHMQ/Home/studentlogin) for status of allotment.
  - b) Candidates who have been allotted a seat shall report at the allotted college within the reporting schedule by downloading the allotment order on payment of University fee details as below:

7. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
8. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
9. Candidates are informed that verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
  - a) If not allotted any seat in Phase-I: Candidates who have not been allotted any seat in the Phase-I of counselling will be considered for available vacancies in Phase-II of counselling with fresh Options.
  - b) If not reported at the allotted college: The candidates who do not report at the allotted college in the Phase-I counselling, will be allowed to participate in the Phase-II counselling with fresh options, provided that the candidates have no right to claim earlier Phase-I allotted seat again under Phase-II counselling.
  - c) If the joined candidates of Phase-I slides to other college during Phase-II of counselling, the Original Certificates of such candidates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along with Custodian Certificate issued by the previous college under Dr. NTR UHS and to pay the Tuition Fee to complete the admission process, failing which the candidate will forfeit the admission.

11. The 2<sup>nd</sup>/Final phase of counselling (exercising web options) will be conducted after the closure of reporting time of 1<sup>st</sup> phase allotments for the available vacancies: -

- A. Unfilled seats in Phase-I
- B. Not reported/Not joined seats after Phase-I

12. **The University fee and other fee once paid shall not be refunded under any circumstance.**
