I am by direction to inform that, the Phase-I of web counselling for All India Quota seats in Private Un-aided Non-minority BAMS & BHMS seats is completed and candidates have to report at the respective BAMS & BHMS Colleges on or before **03.00 PM on 09.11.2024** College wise allotted list of is placed in the University website <http://drntr.uhsap.in>

**The candidates already joined in MBBS or BDS Course during 2024-25 shall discontinue the course duly following the prescribed procedure in order to join in the seat allotted under UG AYUSH Counselling.**

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of the candidates for All India Quota seats in Private Un-aided Non-minority BAMS & BHMS admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a “Committee” consisting of 2 or 3 Professors and Principal as chairman of the Committee to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The “Committee” to be constituted at the colleges, shall arrange for the verification of all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

The list of documents to be verified at the time of admission is enclosed.

**Instructions: -**

1.	The candidates are instructed to visit the website: <a href="https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin">https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin</a> for status of allotment.
2.	The selected candidates can download the provisional allotment order on payment of University Registration Fee through payment gateway and report to the Principal of the allotted college on or before the date specified in the allotment order.
3.	Classes already Commenced from <b>01.11.2024</b> .
4.	<b>UNIVERSITY FEE:</b> Candidates to whom allotment message is given have to pay <b>Rs.8,600/-</b> before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).
5.	<b>TUITION FEE:</b> The selected candidates have to pay tuition fee of <b>Rs.24,500/-</b> per year at the allotted college for admission into AIQ seats in Private BAMS & BHMS Courses in Un-aided, Non-Minority BAMS & BHMS Colleges as per orders of Government of Andhra Pradesh G.O.Ms.No.141 HM& FW (C2) Dept., dt.31.08.2023 & G.O.Ms.No.193 HM& FW (F2) Dept., dt.31.10.2023.
6.	<b>The University fee and other fee once paid shall not be refunded under any circumstance.</b>
7.	The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
8.	The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr. NTR UHS) during subsequent phases of counselling, the original certificates will be sent to the college concerned by the college where the candidate has slide.
9.	After the cutoff date for reporting i.e., by <b>03.00 PM on 09.11.2024</b> , no candidate should be admitted and their Provisional admission is deemed to be cancelled without any further intimation.
10.	Principals have to upload the Report/Not Reported data in the Website <a href="https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin">https://apuhs-ugadmissions.aptonline.in/UGAYUSHAIQ/Home/StudentLogin</a> by <b>04.00 PM on 09.11.2024</b> .
