In view of reduced minimum Cut-off Scores of NEET UG-2024 after lowering of qualifying percentiles released by Ministry of AYUSH/NCISM/NCH, New Delhi, **vide Lr. dt. 11.11.2024 & 12.11.2024**, Dr. NTR UHS invites Online applications from the NEET UG-2024 eligible candidates for Admission into BAMS & BHMS Courses under Competent Authority Quota seats in Government and Private un-aided non-minority BAMS & BHMS Colleges in the State of Andhra Pradesh for the academic year 2024-25.

- a. Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2024-25 notified by AACCC, New Delhi, Vide Ref. No. AA-11013/1/2024-EP-I, dt.17.10.2024, 02.11.2024 & 12.11.2024 are not eligible to participate under this notification.
