In view of reduced minimum Cut-off Scores of NEET UG-2024 after lowering of qualifying percentiles released by Ministry of AYUSH/NCISM/NCH, New Delhi, **vide Lr. dt. 11.11.2024 & 12.11.2024**, Dr. NTR UHS invites Online applications from the NEET UG-2024 eligible candidates for Admission into BAMS, BHMS & BUMS Courses under Competent Authority Quota seats in Government and Private un-aided non-minority BAMS, BHMS & BUMS Colleges in the State of Andhra Pradesh for the academic year 2024-25.

- a. Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2024-25 notified by AACCC, New Delhi, Vide Ref. No. AA-11013/1/2024-EP-I, dt.17.10.2024, 02.11.2024 & 12.11.2024 are not eligible to participate under this notification.
- b. Candidates who have already submitted Online applications for this academic year 2024-25 and whose names are present in the CQ Final Merit list displayed on 30.10.2024 University website need not apply again and they will be considered for remaining rounds of counselling as per Rules.
- c. Fresh registrations will be considered for remaining rounds of counselling for the available vacancies only.
- d. Last date of admissions 20.12.2024.
- e. The other conditions notified in the earlier notifications/Prospectus, dt. 09.10.2024 & 10.10.2024 will remain same.
