

# <u>Dr. NTR UNIVERSITY OF HEALTH SCIENCES: A.P.: VIJAYAWADA - 520 008.</u> NOTIFICATION FOR ADMISSION INTO BAMS, BHMS & BUMS COURSES 2024-25

Notification for inviting common single online application form and uploading of scanned original certificates for Admission into BAMS, BHMS & BUMS Courses under Competent Authority Quota seats available in the colleges affiliated to Dr. NTR UHS, Vijayawada for the Academic year 2024-25 in the state of Andhra Pradesh.

1. Application forms are invited through online from the eligible candidates who have secured the following cutoff scores and more in National Eligibility-cum-Entrance Test (NEET) UG – 2024 and fulfilled the following eligibility criteria for admission into BAMS, BHMS & BUMS Courses under Competent Authority Quota seats available in Government, Private Un-aided Non-Minority Ayurveda, Homoeopathy & Unani Medical Colleges, affiliated to Dr. NTR UHS, Vijayawada for the Academic Year 2024-25 in the state of Andhra Pradesh.

- **2.** The eligible candidates have to submit their application form through online mode only along with uploading the scanned copies of all relevant original certificates.
- **3.** The same application will be considered for all the rounds of the counseling including MOP-UP round counseling and also for stray vacancies, subject of fulfillment of eligibility criteria. There shall not be any offline admission and admission without counselling or any admissions in contravention, admissions made after the cut-off date by any means shall not be approved/cancelled by the NCISM/NCH.
- **4.** This Notification is for determining State Merit position for admission into **Competent Authority Quota seats only** i.e., "the seats remaining after contributing of 15% to All India Quota in Government AYUSH colleges and Category 'A' seats (50% of intake) in Private Unaided Non-Minority AYUSH Colleges under Dr. NTR UHS, Vijayawada".
- **5.** Total number of seats available under Competent Authority Quota for the <u>Academic Year 2024-25 is given in Prospectus.</u>

- 7. The candidates are directed to follow the details /procedure as per the respective Prospectus. State Merit position of the eligible candidates applied for will be prepared basing on the NEET UG 2024 score & Rank and other eligibility criteria notified hereunder, Scrutiny of uploaded data shall be done by the University and concerned Departmental Officials. After scrutiny of certificates, provisional merit list will be released.
- **8.** Final merit position will be released later, after obtaining grievances if any from the candidates.

# 9. Eligibility:

#### 1. Minimum Age: -

- a) Candidates should have completed the age of 17 years as on the 31st December 2024.
- b) Candidates who do not complete 17 years as on 31.12.2024 are not eligible.
- c) Age shall be calculated on the basis of date of birth as Indicated in the Board of Secondary School Certificate Examination (SSC) or Equivalent Examination.
- d) No upper age limit.

### 2. Minimum Educational qualification:

# FOR ADMISSION INTO BAMS, BHMS & BUMS COURSES:

Passing marks for eligibility in admission to ASU&H-UG courses should be as per the ASU&H-UG regulations and should be followed strictly. The details of qualifications for different categories are as follows:

- **For Ayurveda BAMS:** Candidate must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the 10+2 or equivalent examination in the case of General category and 40% Marks in the case of the Scheduled Castes, Scheduled Tribes, and Other Backward Classes.
- **For Homeopathy BHMS:** Candidate must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology/Biotechnology at the 10+2 or equivalent examination in the case of general category and 40% Marks in the case of the Scheduled Castes, Scheduled Tribes, and Other Backward Classes.

#### c) For Unani-BUMS: -

ELIGIBILITY FOR ADMISSION AS PER REGULATIONS of National Commission of Indian System of Medicine, F.No.11-76/2021-BUMS (Unani- UG-Regln.) dated 28.02.2022.

- a) Admissions to Kamil-E-TIB-Wa-Jarahat course: A candidate seeking admission to main Kamil-E-Tib-Wa-Jarahat (Bachelor of Unani Medicine and Surgery B.U.M.S.) Course must have passed.
- b) The candidate shall have pass Intermediate (10+2) or its equivalent examination from any recognized by the concerned State Government and Education Board with subjects of Physics, Chemistry, Biology and English individually and must have obtained minimum 50% marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of general category and 40% marks in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes:
- **c)** Candidate shall have passed Urdu or Arabic or Persian language as on the subject in the 10<sup>th</sup> standard or in 12<sup>th</sup> standard.
- **d)** Candidate who is not covered under clause (b) shall have to study Urdu language along with Arabic and Mantiq Wa-Falsafa (Logic and Philosophy) as a subject during the First professional B.U.M.S session.
- e) The syllabus is applicable to the students admitted in the academic year session 2021-22 on wards for 5 years or until further notification by NCISM, whichever is earlier (Ref.11-79/2020-Unani (U. G. Syllabus) dt.29.03.2021.
- **10**. a) For PwD candidates, PwD certificate should be as per the Guidelines issued by Central Government and notified by the NCISM/NCH, (available on counseling website namely <a href="https://www.aaccc.gov.in">www.aaccc.gov.in</a>
  - b) The candidates who claim for admission under Persons with Disabilities (PwD) category shall mention in the online application that they are applying under PwD category and have to appear before the Medical Board, to be constituted by the Competent Authority and notified by the University for Eligibility under PwD status.
- 11. The candidates who got registered as Persons of Indian Origin (PIO)/ Overseas Citizen of India (OCI) Card holders on or after 04.03.2021 are eligible for admission only against any Non-Resident Indian seat or any supernumerary seat; and shall not be eligible for admission against any seat reserved exclusively for Indian Citizens.
- **12.** Admission into 85% of the seats shall be reserved in favor of the local candidates of AU & SVU Regions in relation to the local area as provided in A.P. Educational Institutions (Regulation of Admission) order, 1974 for Non-State-Wide courses as given in Annexure-III of GO (P) No. 646, Edu. (W1) Department, dt.10-7-1979.
- **13.** As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.
  - ➤ Candidates of OU local area is not eligible for UG AYUSH seats in the State of Andhra Pradesh.
  - > Candidates of OU Local area with AP Domicile (APNL) are eligible for 15% APUR seats
    - in the State of Andhra Pradesh.
  - ➤ NL Candidates are not eligible for UG AYUSH Local seats in the State of Andhra Pradesh.
  - ➤ NL Candidates with AP Domicile (APNL) are eligible for 15% APUR seats in the State of Andhra Pradesh.
  - The candidates who wish to claim seats under CAP (Army), NCC, Persons with Disabilities (PwD) shall fulfill the above eligibility criteria.
  - **14.**The candidates are advised to download and read the respective Prospectus/Regulations carefully before filling the online application form for admission into BAMS, BHMS & BUMS Courses for the Academic Year 2024-25 available in the website <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a> The candidates also have to verify their eligibility under local and non-local category.

# 15. Procedure of filling online application form and for payment of fee through online for Application and Processing Fee for BAMS, BHMS & BUMS Courses.

- a) The fee can be paid through Debit card / Credit card / Net Banking / UPI ID.
- **b)** The fee paid by the applicants is not transferable/refundable under any circumstances.
- c) Read the Detailed Notification, Prospectus/Regulations carefully regarding eligibility under local and non-local.
- d) Visit website through Internet Explorer 11 version only to fill the application form.
- e) The User ID which will be sent to the registered mobile after entering the basic details should be noted for further use. The User ID should be kept confidential and should not disclose to others.
- f) The following Certificates are required to complete the online application process. The certificates are to be scanned and kept ready to upload. Application fee has to be paid through online.

#### 16. Instructions to the candidates:

- a) The candidates are advised to download and read the respective Prospectus of the course and instructions for filling Online Application available in the University Website <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a> before filling the online Application.
- b) Scrutiny of uploaded data shall be done by the University and concerned Departmental Officials. After scrutiny of certificates, provisional merit list will be released and final merit list will be released later, after obtaining grievances if any from the candidates. Candidates are advised to refer to University website <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a> for further notifications / Instructions / Notices regarding schedule for exercising web options.

**Note:** The process of admissions into UG AYUSH courses will be in accordance with the Orders issued from time to time by Ministry of AYUSH/NCISM/NCH/Govt. of India/Government of Andhra Pradesh G.Os.

- c) The On-line application form with the following lacunae will be rejected automatically. No communication will be sent in this regard.
  - If any of the mandatory certificates are not uploaded.
  - Applications with incomplete details.
  - If any of the uploaded certificates are invisible/not properly uploaded.
  - If the certificates are not properly scanned due to which the eligibility criteria cannot be determined.
- d) The verification of certificates will be done basing on the uploaded scanned certificates. No separate notification will be given for verification of Original certificates. The candidates claiming reservation under special categories i.e. PwD, NCC & CAP are advised to watch the University website for further notifications / Notices.
- e) Hence, the candidates should register and upload all the mandatory certificates and without fail and verify once again before submission of online application.
- f) The candidate should submit the Printout of the filled in Online application form personal verification status along with all Original certificates along with One set of self attested Copies to the Principal of allotted college at the time of joining for final verification. In case of any discrepancy, the Provisional allotment order will be cancelled without any notice.
- g) The candidates are informed not to send the print out of application form to the University.
- 17. Candidate's admission is strictly provisional. The mere fact that the merit position issued to him/her does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him/her in the online application are accepted as true and correct. The candidates eligibility for admission into BAMS, BHMS & BUMS Courses for the academic year 2024-25 will be examined by the University officials and officials of the concerned department only basing on the uploaded scanned original certificates.

An in-eligible candidate obtaining merit position does not make him/her eligible for admission.

He/she may please note that the University will take up the verification of original certificates with regard to eligibility conditions i.e., Educational Qualifications, Local/Non local area status, category etc., at the time of joining at the allotted college.

18. If the information furnished by candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken. If the certificates produced by any candidate are found to be fake / false/forged at any stage of verification or admission, the University has every right to cancel the seat / admission of such candidate without any notice.

- 19. In case of discrepancy in the downloaded provisional verification form, the same shall be brought to the notice of the University immediately.
- 20. Subsequent notifications with regard to web counseling will be notified on the University website only. Please visit the university website <a href="https://drntr.uhsap.in">https://drntr.uhsap.in</a> regularly for subsequent notifications/ instructions till the completion of admission process. No individual instructions will be sent.
