Vide letter No. NCISM/Examinations/StateDME/2024, dated: 20.12.2024 from the Secretary, NCISM, New Delhi & Letter No. 3-5/2024/NCH/HEB/Ayush UG Adm. 2024-25/7374-7387, dated: 20.12.2024 NCH, New Delhi, the Cut-off date/last date for admission into BAMS & BHMS Courses has been extended from 20.12.2024 to 31.12.2024. In view of this extended date, the Competent Authority has decided to fill the not-reported seats if any after Stray Vacancy Round, for which registration is re-opened for the candidates who are seeking admission into UG AYUSH Courses for the academic year 2024-25.

#### 3) INSTRUCTIONS TO THE CANDIDATES:

- 1. Candidates who are not holding any seat of BHMS/BAMS of Central quota or State quota are only eligible to apply under this notification.
- 2. Candidates who are already present in the earlier merit list are also eligible provided they should not hold any seat in Central quota or State quota. Such candidates need not apply again.
- 3. If the candidate is allotted a seat under this notification, he / she has to report in the allotted college compulsorily.
- 4. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct
- 5. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
- 6. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
