Notification for exercising web options for Stray Vacancy Round-1 of web-based counseling for admission into **BAMS**, **BHMS & BUMS** Courses under **Competent Authority Quota** Seats in Government, Private Un-aided Non-Minority BAMS, BHMS & BUMS colleges under Dr. NTR UHS for the academic year 2024-25.

All the eligible candidates who have registered for UG AYUSH 2024 counselling are hereby informed that some seats are still lying vacant due to Non-Joining / Non reporting after completion of Stray Vacancy Round of UG AYUSH counselling 2024. The details of the vacant seats are notified under this Notification.

In view of the above, the Competent Authority has decided to conduct another round of Special Stray Vacancy Round for the vacant seats by converting them into APUR/Open/General, so the seats do not go waste.

General Instructions:

- 1. The seats that are vacant due to non-reporting after Stray Vacancy Round will be filled in this round.
- 2. Candidates who are not holding any seat of BHMS/BAMS/BUMS of Central quota or State quota (Competent Authority Quota & Management Quota) are only eligible to apply under this notification.
- 3. All the eligible candidates who are in the Merit list notified in the website on **27.12.2024** eligible to exercise their options.
- 4. Candidates who are already present in the earlier merit list are also eligible provided they should not hold any seat in Central Quota or State Quota. Such candidates need not apply again.
- 5. The candidates who are allotted in Stray Vacancy Round are not eligible to participate in this Round.
- 6. If the candidate is allotted a seat under this notification, he / she has to report in the allotted college compulsorily.
- 7. As the seats are precious in nature, the not-reported candidates if any, will be recommended to the NCISM, New Delhi for debarment from NEET UG 2025. Hence, the candidates are requested to be cautious while opting under this Notification.
- 8. If they are not interested to join any course or college then they are advised not to exercise options for the same.
- 9. The mere fact that the Merit position issued to the candidate does not imply that the candidature is accepted by the University and it does not mean that the entries made by the candidate in the online application are accepted as true and correct.
- 10.If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.

Information Regarding BUMS Course:

- 11.BUMS Course is governed by the Regulations, dated.28.02.2022 of the National Commission for Indian System of Medicine. These regulations are available on NCISM website which may be read well for various information on eligibility, qualification, medium of instructions etc.
 - a) The candidate shall have passed Urdu or Arabic or Persian language as on the subject in the 10th standard or in 12th standard.
 - b) The candidate who is not covered under clause(b) shall have to study Urdu language along with Arabic and Mantiq Wa Falsafa (logic and Philosophy) as a subject during the First professional B.U.M.S. session.
- 12. An in-eligible candidate obtaining Merit position does not make the candidate eligible for admission.
