



Dr. NTR UNIVERSITY OF HEALTH SCIENCES: ANDHRA PRADESH: VJA – 8

Notification for exercising web options for Phase-III of web-based counselling for admission into BAMS, BHMS & BUMS Courses under Competent Authority Quota Seats for the academic year 2024-25.

In continuation of earlier notification dated 30.10.2024 & 05.12.2024 the University hereby notifies the Phase-III of web-based counselling for BAMS, BHMS & BUMS seats available under Competent Authority Quota including Special Categories in Government, Private Un-aided Non-Minority, Aided BAMS, BHMS & BUMS colleges (under Dr. NTR UHS) for the academic year 2024-25 in the state of Andhra Pradesh.

All the eligible candidates who are present in the Final Merit Position notified in the website on **04.12.2024** are only eligible to exercise their options as per the seat matrix displayed on the **website <https://drntr.uhsap.in>**

The seat allocation will be done as per the Procedure given in G.O.P.No.646, Education (w) dept. Dt.10-07-1979 as amended in G.O.Ms.No.42, Higher Education dept., Dt.18-05-2009 and as per the G.O. Ms No.131 HM&FW (R2) Dept., dt:25.04.2008 as amended in G.O.Ms.No.8, HM & FW(F2) Dept., dt.29.01.2021.

UNIVERSITY FEE: Candidates who are allotted with a seat, have to pay **Rs. 8,600/-** before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).

TUITION FEE: 1. Govt. Colleges: Fee as fixed by the Govt. of Andhra Pradesh.

2. Private Colleges: The selected candidates have to pay tuition fee of **Rs.24,500/-** per year for admission into BAMS & BHMS Courses as per orders of Government of Andhra Pradesh G.O.Ms.No.141 HM & FW(C2) Dept., dt.31.08.2023 & G.O.Ms.No.193 HM & FW(F2) Dept., dt.31.10.2023.

Instructions to the Candidates:

Candidates whose names are found in the Final list of In-eligible candidates for AACCC/State/UT AYUSH UG counselling 2024-25 notified by AACCC, New Delhi, Vide Ref. No. AA-11013/1/2024-EP-I, dt.17.10.2024, 02.11.2024, 12.11.2024 29.11.2024 & 11.12.2024 are not eligible to participate under this notification.

1. Candidates present in the Merit list are eligible to participate in Phase-III counselling with fresh options as per eligibility.
2. If a candidate has taken seat in the Phase-I or Phase-II of counselling can slide in the Phase-III of counselling also.
3. Phase-II seats vacated because of sliding to other colleges during the course of Phase-III counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules.
4. Original Certificates will be sent after closure of admission to the newly allotted college from the previous college, candidate has to report to the newly allotted college within custodian certificate which was issued by the previous college under Dr. NTR UHS only after completion of the university procedure by paying fee etc., failing which candidate(s) and admission will forfeit or stands cancellation.

5. Candidates who have already joined under MQ or AIQ under Dr. NTR UHS are eligible to participate in Competent Authority Quota Phase-III counselling with fresh options. In such cases, if seat is allotted, they can join the seat with the custodian certificate issued by the previous college. They will not have claim on the vacated seat under AIQ/MQ.
6. Candidates allotted seats in CQ/Phase-III will be eliminated before processing MQ/AIQ allotments though they exercised options. Therefore, candidates should take calculative decision in choosing options for CQ or AIQ/MQ.
7. The candidates already joined in MBBS or BDS Course during 2024-25 are not eligible for UG AYUSH course for the academic year 2024-25.

9. Candidates are further requested to opt for all the colleges irrespective of the vacancies available.
10. Area wise seat matrix is displayed on University website on 30.10.2024 for the information to the candidates to exercise their options.
11. Conversions will be done as per rules.
12. **Allotments under Special categories:**
 - The unallotted seats under special categories will be added to respective categories, since the seats under special categories are Horizontal Reservations.
13. Candidate can give options on the web either from home or any other place having internet facility.
 - a. One Time Password will be sent to the registered mobile at the time of registration and also at the time of saving Web options.
 - b. The password consists of SIX letter code with English capitals A to Z.
14. A candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
15. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
16. Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the [website: https://drntr.uhsap.in](https://drntr.uhsap.in) for status of allotment.
17. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
18. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
19. **FOR BUMS:** As per F.No.11-76/2021-BUMS (Unani-UG Regl.) dated.28-02-2022 the following is the regulation on Eligibility for admission into BUMS course which is applicable from the academic year 2021-22:
 - a. The candidate shall have passed 10+2 or its equivalent examination from any recognised Board with physics, Chemistry and Biology and shall have obtained a minimum of 50%. Marks taken together in Physics, chemistry and Biology in the case of general category and 40% marks in the case of Scheduled Castes, Scheduled Tribes and other Backward classes: -

Provided that in respect of persons with disability candidate specified under the rights of persons with disabilities act, 2016 (49 of 2016) the minimum qualifying marks in the said examinations shall be 45% in the case general category and 40% in the case of Scheduled Casts, Scheduled Tribes and other Backward Classes.

- b. Candidate shall have passed Urdu or Arabic or Persian language as on the subject in the 10th standard or in 12th standard.
- c. Candidate who is not covered under clause(b) shall have to study Urdu language along with Arabic and Mantiq Wa Falsafa(Logic and Philosophy) as a subject during the First professional B.U.M.S. session.
- d. The syllabus is applicable to the students admitted in the academic year session 2021-22 onwards 5 years or until further notification by NCISM, whichever is earlier (Ref.11-76/2020-Unani (U.G Syllabus) dt.29-03-2021).

Information regarding Mop-up

20. There is no upgradation after Phase-III of counselling.
21. Mop-up of counselling will be conducted with fresh options for the available seats after completion of Phase-III counselling.
22. **If not allotted any seat:** Candidates who have not been allotted any seat in any Phase of counselling will be considered for available vacancies in Mop-up Round of counselling with fresh Options.
23. Candidates not reported in Phase-I or Phase-II are eligible to Participate in Mop-up Round of counselling.
24. Candidates reported in Phase-I or Phase-II are not eligible to Participate in Mop-up Round of counselling.
25. Candidates allotted in Phase-III are not eligible to Participate in Mop-up Round of counselling.
26. **The University fee once paid shall not be refunded under any circumstances.**
