## NOTICE

It is to bring to your kind notice that the Andhra Pradesh State Counselling for NEET (PG)-2023 was successfully conducted and after completion of all the 3 Rounds of counselling, two Stray vacancy Rounds and two Special Stray vacancy Round was proposed and was conducted with the following condition:-

- 1. In case, a candidate has participated in Stray Round/Special stray vacancy round wherein he/she has been allotted a seat & fails to report to his/her allotted college. Such a candidate shall be debarred for one academic year i.e., 2024-25 for admissions into Medical Colleges in the State of Andhra Pradesh.*

However, even after the conduction of Stray/Special Stray Rounds, a total of **34 candidates failed to report at the allotted college**. Hence, as per the terms and conditions of the Stray /Special Stray Vacancy Round, these 34 candidates will not be eligible to participate in the counselling process of NEET (PG)-2024-25

In reference to the same, the details of these 34 candidates were verified, if any of them have applied to Dr. NTRUHS Notification for admission to PG Medical Courses under Competent Authority Quota (CQ) and Management Quota (MQ) for the academic year 2024-25 dated 27/09/2024 & 05/11/2024 and a total 9 candidates have been traced who applied for the said notifications under CQ and a total 6 candidates have been traced who applied for the said notification under MQ and had not joined seat in Stray/Special Vacancy Rounds. Accordingly, **these 15 (9+6) candidates plus one (1) candidate who discontinued as per the conditions specified in G.O.Ms.No.67 dt 21.04.2017 will be ineligible to participate in the AP State counselling process of NEET (PG)-2023-24 under CQ & MQ (Copy attached).**
