Note: The candidates of other States are not eligible for the Competent Authority Quota seats if they do not satisfy Local status/Non-Local status as per G.O.P.NO. 646, Education (W) Department, Dated 10th July, 1979 of Government of Andhra Pradesh (Presidential Order) and as clarified vide Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 of Govt. of Andhra Pradesh.

Online Application forms are invited from the eligible candidates for admissions into Post Graduate Medical Degree/Diploma courses in Government and un-aided Private Non-Minority & Minority Medical Colleges under Competent Authority Quota seats for the academic year 2024-25 in the colleges affiliated to Dr. NTR University of Health Sciences.

2. Candidates are advised to visit the University website for all further notifications/latest updates/circulars/allotments on PG (Medical) Admissions till the closure of admissions. No individual communications will be sent.
3. Online applications are invited from eligible In-service candidates as per G.O.Ms.No.85, HM&FW (C1) Dept., dt.20-07-2024, Govt. of A.P for admission into service quota seats in PG Medical Courses from the academic year 2024-25 and **subject to any modifications as notified by the Government from time to time and court directions if any,**
4. Service rendered up to **16-04-2024** shall be considered for considering candidates under In-service Quota seats.
5. Service candidates should not have completed 50 years as on **16-04-2024**. Candidates born on or before **16-04-1974** are not eligible for In-service quota seats only.
6. As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 of Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.

7. Filling up of 36% of Seats (earlier meant for OU/KU area) in Siddhartha Medical College, Vijayawada from 2024-25:

The Government of Andhra Pradesh vide G.O.Rt.No.513, HM&FW (C1) Dept., dt.08-08-2024 ordered "to continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution by excluding the 36% of seats reserved and allocated to local candidates from the Osmania or Kakatiya University Local Areas (Telangana Area) under the 1974 Order. These seats shall be exclusively allocated to candidates from the state of Andhra Pradesh to comply with the requirements of Paragraph 6 of the 1974 Order read with Article 371 D of the Constitution of India. The 36% seats shall be distributed among the local candidates relating to both Andhra and Sri Venkateswara University Local Areas and can be filled by merit duly implementing the statutory reservations as applicable, to protect the interests of the students of Andhra Pradesh, until a fresh/modified Order is obtained from the Hon'ble President of India at the earliest opportunity."
