**Prospectus for Admission into M.Sc(Nursing) Courses under Competent Authority**  
**Quota/State Quota seats for the Academic Year 2024-25.**

**REGULATIONS:**

The following are the Regulations for admission into M.Sc., (Nursing) courses under Competent Authority Quota (CQ Seats) in all affiliated Colleges to Dr.NTR UHS in the State of Andhra Pradesh for the academic year 2024-25.

**1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA**

- 1.1 The number of colleges and seats for admission into first year M.Sc., (Nursing) courses for the academic year 2024-25 Annexure IX are given in page no 27.
- 1.2 **In case any new Colleges/Courses are affiliated to the University for starting the M.Sc., (Nursing) Courses for the academic year 2024-25, those seats will also be filled up. NO FURTHER NOTIFICATION WILL BE ISSUED.**
- 1.3 Some of the Colleges have given willingness to admit both male and Female candidates and the seats for male candidates will be allotted as per rules.
- 1.4 The selections will be made to the above colleges subject to affiliation for the academic year 2024-25.
- 1.5 As per G.O.Ms.No.338, HM & FW Dept., dated 16-08-2008, if sanctioned intake capacity is odd number, equal seats will go to management quota and Competent Authority Quota and odd seat will be rotated between the management quota and Competent Authority quota year after year.
- 1.6 The details of the seats available and Seat matrix under Competent 'authority Quota for the Academic Year 2024-25 will be displayed in the University website at the time of counseling.

**2. ELIGIBILITY:**

- 2.1 **Educational Qualification:** The candidate should have passed B.Sc., (Nursing) /B.Sc., Hons (Nursing)/Post Basic B.Sc., (Nursing) from an Institution which is recognized by the Indian Nursing Council with minimum of 55% aggregate marks and 5% relaxation of marks for SC and ST candidates.
- 2.2 **Age:** No Upper age Limit as per INC Regulation Vide F.No.1-6/(LT)-2023-INC. dt.01.02.2024.
- 2.3 **Gender:** Both women and men candidates are eligible to apply for the M.Sc (Nursing) as per GO .Ms. No. 77, HM & FW (K1) Dept, dated 13.06.2013. Regarding male candidate, admission will be as per G.O.Ms.No.79, HM & FW (K1) Dept, dated 17.06.2013. Admission for male candidates will be considered in colleges where the principals have agreed to admit male candidates.
- 2.4 **Registration with Nursing Council:** Candidate should be a Registered Nurse and Registered Midwife of Indian Nursing Council / State Nursing Council for Service and Non--Service candidates.
  - In case of B.Sc., (N) candidates, those who registered in Nursing council prior to 31.10.2023 are only eligible. Those who registered after 31.10.2023 are not eligible for this academic year 2024-25.
  - In case of Post B.Sc., (N) candidates those who registered in Nursing council prior to 31.10.2024 are only eligible. Those who registered after 31.10.2024 are not eligible for this academic year 2024-25.

2.5 **Experience for Regular Candidates (Non – Service Candidates):**

- i. Minimum one year of work experience after Registration of B.Sc., (Nursing) Degree in Nursing council as on **31-10-2024** is required. That means the candidates who registered in Nursing council as on 31.10.2023 are only eligible and those who registered in Nursing council after 31.10.2023 are not eligible as they will not complete one year experience by 31.10.2024.
- ii. Minimum one year of work experience prior or after Registration of Post Basic B.Sc., (Nursing) courses as on **31-10-2024**.

**Note:** Experience Certificate once submitted is final. No alterations/ no Revised service certificate will be accepted after submission of application. The candidates who have not acquired relevant service and not submitted requisite service certificate, such applications will be rejected and no further correspondence will be entertained. Therefore, candidates are advised to check the application before submitting.

2.6 **Physical fitness):** The candidate shall be medically fit.

2.7 **Post Basic B.Sc(Nursing) from IGNOU:**

- i. The candidates who qualified Post Basic B.Sc., (Nursing) from IGNOU through distance education are also eligible, if the study centre is recognized by Indian Nursing Council.
- ii. The candidates, who completed Post Basic B.Sc., (Nursing) from any IGNOU study centers can make application for admission into M.Sc., (N) course provided they have taken admission in IGNOU study centers prior to year 2012. The students who have undergone P.B.B.Sc.,(N) course from IGNOU after this date are eligible for admission into M.Sc.(N) only if the study centers are recognized by IGNOU.

3. **RESERVATION IN FAVOUR OF THE LOCAL CANDIDATES:**

- i. Admission to 85% of the seats shall be reserved in favour of the local candidates in relation to the local area as provided in A.P. Educational Institutions (Regulation of Admission) order,1974for Non-Statewide courses as given in Annexure-III of GO (P) No. 646, Edu. (W1) Department, dt.10-7-1979.

3.1.1 **LOCAL AREA:**

3.1.2 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the local area in respect of the Andhra University and the Nagarjuna University area.

3.1.3 The part of the State comprising the Districts of Anantapur, Kurnool, Chittoor, Kadapa and Nellore shall be regarded as local area in respect of S.Venkateswara University area and the Sri Krishna devaraya University area.

3.2 **LOCAL CANDIDATES:**

3.2.1 A candidate for admission to any course of study shall be regarded as local candidate in relation to a local area

- i. If he/she has studied in an educational institution(s) in such local area for a period of not less than four consecutive academic year ending with the academic year in which he/she appeared or as the case may be first appeared in the relevant qualifying examination

(or)

- ii. Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which he/she appeared or as the case may be first appeared.

3.2.2 A candidate for admission to any course of study who is not regarded as a local candidate under sub regulation above in relation to any local area shall

- i. If he / she has studied in an educational institution in the state for a period of not less than seven (7) consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as a local candidate in relation to:
  - a) Such local area where he/she studied for the maximum period out of the said period of 7 years;
  - b) Where the period of his/her study in two or more local areas are equal, such local area where he /she studied last in such equal periods;

(or)

- ii. If during the whole or any part of the seven consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for relevant qualifying examination, he/she has not studied in the educational institution in any local area, but he/she has resided in the State during the whole of the said period of 7 years be regarded as a local candidate in relation to

- a) Such local area where he/she has resided for the maximum period out of the said period of 7 years

(or)

- b) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

(or)

- c) Local status certificate issued by MRO for claiming as AP local as per Circular Nos.4136/SPF&MC/2015-5, dated.08.08.2016 and 4136/SPF&MC/2015-13, dt. 20.11.2017

3.3 **EXPLANATIONS:** For the Purpose of this regulation

- i. "Educational Institutions" means a university or any educational institution recognized by the State Government, a University or any other competent authority:
- ii. "Relevant qualifying examination" in relation to admission to any course of study, means the examination, a pass in which the minimum educational qualification for admission to such course of study.

**Note:** The relevant qualifying examination for admission into M.Sc(Nursing) courses is B.Sc(N) examination. The question whether the candidate is a local candidate or not will be determined with reference to his/her first appearance in the final B.Sc (Nursing) examination.

- iii. In reckoning the consecutive academic year during which a candidate has studied any period of interruption of his/her study by reasons of his/her failure

to pass any examination and any period of his/her study in a statewide University or a statewide educational institution shall be disregarded.

- iv. The question whether any candidate for admission to any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his/her parent or guardian.
- 3.3.1 While determining under sub-regulation 3 (i) the number of seats to be reserved in favour of local candidates, any fraction of seat shall be counted as one, provided that there shall be one unreserved seat.
- 3.3.2 If a local candidate in respect of a local area is not available to fill any seats reserved or allocated in favour of local candidate in respect of that local area such seats shall be filled in as if it had not been reserved.
- 3.3.3 The applicant who claims to be local candidate with reference to sub-regulation 3.2.1 (i) or 3.2.2 (i) shall produce in the form of study certificate/certificates issued by the Head of the Educational Institution / Institutions concerned indicating the details of the year or years in which the candidate candidate has studied in educational institution in such local area for a period of not less than 4/7 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first .

Those who did not qualify as local candidate under sub-regulation 3.2.1 (i) or 3.2.2 (ii) but claim to qualify by virtue of residence shall produce a certificate issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer independent charge of subtaluk/Mandal in the form annexed to G.O.P.No.628, Education, dated 25-7-1974 appended as Annexure – I.

- 3.3.4 **The following categories of candidates are eligible to apply for admission to the remaining 15% of AP Unreserved seats.**

As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/ Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.

- a. All the candidates eligible to be declared as local candidates of two local areas of State of Andhra Pradesh.
- b. Candidates, who have resided in the State of Andhra Pradesh for a total period of ten years excluding periods of study outside the State, or either of whose parents have resided in the State of Andhra Pradesh for a total period of ten years excluding periods of employment outside the state.
- c. Candidates who are children of parents who are in employment of the State of Andhra Pradesh or Central Government, Public Sector Corporations, Local Bodies, Universities and Educational Institutions other similar quasi Public Institutions within the State of Andhra Pradesh.
- d. Candidates who are spouses of those in the employment of the State of Andhra Pradesh or Central Government, public sector corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University or other Competent Authority and similar quasi Government Institutions within the State of Andhra Pradesh.”



**Note:** Relevant scanned original certificates must be uploaded along with application in respect of their claim for 15% Unreserved seats. In respect of proof of 10 years residence, the certificate should be obtained from the Revenue Authorities and the issuing Officer shall not be below the rank of Mandal Revenue Officer / Tahsildar.

#### **4. SERVICE CANDIDATES:**

As per the G O. M S. No. 156, dated. 08.12.2016 of HM & FW (E), Dept., Govt. of AP, Velagapudi, Andhra Pradesh, 40% of seats out of total number of seats available at Sri Padmavathamma Government College of Nursing, Tirupati, and 40% of seats available at Govt. College of Nursing, Kurnool as per G.O.M.S No.86, dt. 07.08.2019 will be allotted for service candidates.

- 4.1 The quota for in-service Nursing Personnel admitted to M.Sc., (N) course in Sri Padmavathamma Government College of Nursing, Tirupati and Government College of Nursing, Kurnool shall be allowed up to 40% and the period of their study shall be treated as “Deputation”. The selected candidates should submit orders of deputation from their respective state Government.
- 4.2 The period of required service in the Government for making application to the M.Sc., (Nursing) course is (5) years.
- 4.3 In the event of leaving the studies during the course period (or) in case of failure to serve the Government for (5) years after completion of the M.Sc., (Nursing) course, the individual has to pay an amount of Rs. 2,00,000/- (Rupees two lakhs only) besides refund of the amount received as salary up-to the date, to the Government.

#### **4.4 ELIGIBILITY CRITERIA UNDER IN SERVICE QUOTA:**

- a. Candidates are working on Government/Regular bases are only eligible
- b. Services Candidates should be a regular employee of the Government of AP/Telangana as per the para 12 of AP Education Institutes (Regulations of Admissions) order 1974 (AP Medical & Health Services and AP Vaidya Vidhana Parishad / Telangana Vaidya Vidhana Parishad) and should have put in not less than 5 years of Service in the said Dept., in any capacity in Nursing as on **31-10-2024**.
- c. Seats Allocated to In-Service Candidates which become vacant after second counselling will automatically be reverted to non-service for further counselling
- d. As per INC regulations, New Delhi the maximum period to complete the course successfully should not exceed (4) four years.

#### **5. RESERVATION:**

- 5.1 Seats of Post Graduate M.Sc(Nursing) Courses are reserved for SC, ST and BC and BC sub groups as detailed below, which are called vertical reservations.

## **5.2 CERTIFICATION OF CASTE CATEGORY:**

5.2.1 Scheduled Caste, Scheduled Tribe and Backward Class candidates shall in support of their claim, have to furnish latest Integrated Caste Certificate with Barcode obtained from Government of AP/Telangana in the prescribed form issued by the Concerned Authority.

If the certificate is not in the prescribed form, candidates will not be considered for selection under the reserved quota.

5.2.2 Caste certificates of other States will not be accepted & in such cases the applied candidate will be considered under General category only.

5.2.3 The social status of the candidates who have applied for the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Classes shall be scrutinized in terms of G.O.Ms.No.58 SW (J) Dept, dated.12-5-1997.

5.2.4 In case of Minority candidates, the Minority certificate issued by Minorities Welfare Department, Government of AP to be furnished in support of their claim

## **6. RESERVATION FOR PERSONS WITH BENCHMARK DISABILITY (PwBD):**

6.1 Out of the available seats for admission by the Dr. NTR University of Health Sciences, 5% shall be reserved for the Persons with Benchmark Disability (PwBD) in each categories of OC, SC, ST, BC-A, BC-B, BC-C, BC-D and BC-E as per Government of India guidelines as per the availability of seats.

6.2 The candidates seeking the benefit of reservation under PwBD category should enclose a valid disability certificate issued not later than three months (03) prior to submitting his/her application.

6.3 The Medical Board constituted by the University will scrutinize/verify the disability certificates as per G.O. MS.No.31, Women development, Child welfare & disabled welfare (DW) department, dated.01.12.2009 and candidates claiming reservation under PwBD quota for conformation of eligibility and the decision of Medical Board specially constituted for the purpose is final and binding on the candidates.

6.4 The Medical Board constituted by the University will scrutinize/verify the disability certificates as per the University Guidelines regarding admission of students with “Specified Disabilities” under the Rights of Persons with Disabilities Act, 2016 with respect to admission in M.Sc(Nursing) Courses.

## **7. APPLICATIONS THROUGH ONLINE:**

The on-line application forms will be available on the Website **from 11.00 AM on 21.12.2024 to 09.00 PM on 26.12.2024**

7.1 The candidates are advised to take a print out of the Prospectus / Instructions from the website <https://drntr.uhsap.in> before proceeding to fill the application form.







The candidate should fill the online application form available on the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates ready to enter his/her correct data.

### **7.2. Procedure of filling online application form and payment of fee through online:**

The fee can be paid through Debit card / Credit card or Net Banking.
