The tentative schedule as per Academic Calendar 2025, the MDS part II examination are to be conducted in the month of May/June, 2025.

- a. The students who have admitted for the academic year 2021-22 batch.
- b. The students who have not appeared for the examinations in earlier and not submitted their dissertations up to batch 2021-22.

Hence, the following guidelines and instructions should be followed in submitting Dissertations which are to be sent for Evaluation by the examiners.

1. The University has introduced **Plagiarism Software** for PG Dissertations. Hence the **students shall check dissertations with Plagiarism M/s. Drillbit Softtech India Pvt. Ltd, Bangalore and submit the Plagiarism certificate** to that effect along with Dissertation CDs duly signed by concerned HOD and have to submit three copies of the Dissertations Soft Copy (CDs) to the University as per the dates mentioned below for forwarding to the External Examiners for Evaluation. The following is the fee particulars.

a) Dissertation fee Rs. 3,000/-

b) The last date for receipt of the Dissertation : 22.02.2025

2. **Therefore, the Principals are advised to collect and remit the Dissertation of fee all candidates through online payment mode on the following link <https://drysr.uhsap.in/epay/>.**

3. The Principals are informed to direct the candidates to submit the **dissertations CD's in PDF format only for convenience to open and evaluate by the examiners easily.**

4. The students have to submit two more copies of the Dissertation at their concerned colleges which are to be retained by the respective HOD's / College Offices for evaluation by the concerned Internal Examiners.

5. **The Referred candidates those who have earlier submitted their Dissertation soft copies 3 (CD's) need not submit for this examination.**
6. The approval of Dissertation shall be a precondition for the candidates eligibility to appear for the final examinations.
7. The candidates whose dissertations are not approved by the examiners will not be allowed for the examinations.
8. The Dissertation will not be accepted by this University after the last date 22.02.2025.
9. This may be brought to the notice of all the concerned students and staff immediately.
10. Kindly acknowledge receipt of this letter.
11. The Principals of all colleges are requested to submit the particulars of the students who submitted dissertations in the proforma Annexured.
