GENERAL INSTRUCTIONS TO THE PRINCIPALS AND STUDENTS (Read all the Instructions carefully)

- 1. The Principals are required to furnish attendance of all the candidates by calculating the attendance up to the last working day of course/term. There is no provision for condonation of attendance. The colleges should maintain the attendance Registers of students properly.
- 2. Internal Assessment marks and Attendance particulars uploaded for December,2024/ January, 2025 examinations will be considered in respect of failed candidates and absentees only.
- 3. In case of students detained due to shortage of attendance for December, 2024/January, 2025 examination, remedial classes to be conducted as being done for referred students during the interim period and the attendance should be uploaded/submitted on or before 15-03-2025 for Second Professional MBBS (NS), Third Professional MBBS Part-I (OR/NS), Third Professional MBBS Part-II (NS).
- 4. Fresh Internal Assessment and Attendance particulars of all the detained/not registered students of December, 2024/January, 2025 Examinations duly signed by Head of the Department and counter signed by the Principal should be uploaded/submitted on or before 15-03-2025 for Second Professional MBBS (NS), Third Professional MBBS Part-II (NS).
- 5. The Internal Assessment Marks and Attendance once uploaded/submitted and freezed shall be final and no changes will be entertained later. THE ATTENDANCE PARTICULARS OF ALL STUDENTS IN THE GALLEY MUST BE UPLOADED IN MEDHAS PORTAL.
- The student is not eligible to appear for the University exam if he/she does not appear for Internal assessment exams or if the Internal assessment exam marks & attendance percentage are not uploaded/submitted on or before 15-03-2024 for Second Professional MBBS (NS), Third Professional MBBS Part-II (NS). In such case the candidate will be detained and no changes will be entertained later on.
- 7. The INTERNAL ASSESSMENT MARKS <u>uploaded/submitted after the last date</u> will not be considered for declaration of result for which the Principal is solely held responsible.
- 8 The Principal should submit the list of candidates who have not applied for the examination in separate cover along with list of applied candidates.
- 9 All the Candidates appearing for Second Professional (NS), Third Professional Part-I (NS) and Third Professional Part-II (NS) shall have attended at least 75% of the total number of classes in theory and 80% in Practical/Clinical, jointly to become eligible to appear for the examination in that subject/subjects as prescribed by NMC/Dr.NTR UHS.

- 10. The Principal should verify all the filled data submitted/uploaded into the MEdHAS PORTAL for eligibility of students and submit to the Controller of Examinations on or before the specified dates. The Principal will be held solely responsible, if any ineligible candidates are permitted to write examination.
- 11. The Principals of concerned colleges are requested to furnish the detailed information and remarks in respect of the candidates who filed writ Petition in the Court regarding their admissions etc, if any. (The candidates whose admissions are not approved shall not be issued Hall Tickets and will not be permitted to appear for the exams).
- 12. The Principals are advised to form a Committee with concerned Head of Departments under Chairmanship of Principal/Vice-Principal who shall be responsible for forwarding examination applications and releasing Hall tickets as per eligibility.
- 13. Instructions/directions as issued previously by the University and Team MEdHAS for uploading of Internal Assessment, Attendance, Practical & Orals are to be adhered to scrupulously.
- 14. While uploading the candidates details the Principal has to take care to see that the scanning of the Photo & Signature of the candidate is done in the given space visibly. The Signature of the student should be visible and legible. The signature should be done with black ink pen in the given space and size of the box only, so as to avoid the delay or last minute issue of Hall Tickets.

- 15. The details entered in MEdHAS Portal by the Principal are final and Hall Tickets will be issued accordingly.
- 16. Competency Based Under Graduate Curriculum to be implemented from August, 2019 i.e., MBBS batch admitted in First year. Batches admitted and studying currently in MBBS shall continue with the existing Curriculum.
- 17 The Colleges should not collect Examination Fee from the Ineligible candidate such as who have failed in IA marks and who have shortage of attendance as per the Dr.NTR UHS/NMC Rules.
- Please notify the contents of this Office Lr. No. 13742/E1/MBBS/2015, dt. 17-04-2021 of the Controller of Examinations, Dr.NTR UHS with regard to Question wise page allocation in the Answer booklets from 2019 batch onwards to all the students and staff concerned (enclosed).

- It is to notify that as per the Judgement dated 04-11-2022 in Civil Appeal No.8037/2022 with Civil Appeal No.8038/2022 of Hon'ble Supreme court of India, there is no provision for revaluation of answer scripts as the procedure adopted by the University in Digital evaluation of answer scripts is upheld by the Apex Court.
- It is hereby notified that in view of introduction of online mode of payment of fee by the University all the applications for retotaling of answer scripts will be accepted through online portal.
- 23 As informed there shall be no grace marks for passing in an examinations under (New Scheme)
