The Notification is issued for registration of candidates to appear for Super SpecialityRegularTheory Examinations scheduled to be held from 25.03.2025 to 01.04.2025.

ELIGIBILITY TO APPEAR FOR EXAMINATIONS:

1. The Super Speciality students who are admitted into the medical colleges affiliated to DrNTR UHS, Andhra Pradesh, whose admissions are approved by the Dr NTR UHS during the academic year 2021-22 and the students who were failed, detained and not registered for Super Speciality examinations conducted earlier are also eligible, if fulfilled the eligibility, to appear for examinations to be held in the month of March, 2025. Students should put **80% Attendance of working days for three years course (by 20.03.2025)**. However, period of training will be extended by the same number of days for which maternity /paternity/ any other leave have been availed in three years.

The Principal concerned should submit study period completion certificate of the students. The result of those students who didn't complete study period by exams will be announced after receipt of study period completion certificate from the Principal.

2. The attendance certificate in respect of each candidate duly signed by the HOD and counter-signed by the Principal indicating the Academic Year / Batch of Admission, Date of Admission (Date of Joining), Details of leave availed, Total number of leave days availed, Attendance percentage, Date of completion of study period must be furnished in the prescribed standard proforma along with the uploaded freeze copy of students' data. A model copy of the attendance certificate is enclosed herewith. **No other format is to be used.**

3. Dissertations of Super Speciality Students should be approved by two external examiners and to get eligibility to appear for examinations. Hall Tickets will not be issued to those students whose dissertations are not approved by the external examiners. The student cannot be prevented from appearing in the examination if he has not obtained the approval of dissertation/thesis from the HOD.
4. Thesis submission certificate is also to be enclosed. The candidates of Super Speciality Examination must submit two testimonial certificates duly issued by two Professors, separately, in the prescribed standard proforma duly enclosed.
5. **Completion of Online Course in Research Methodology is mandatory for publication of results and the candidates should submit Online Course in Research Methodology completion certificate.**

6. As per NMC Post Graduate Medical Education Regulations, 2023, Under 5.2 (x):

A Super Speciality degree student has to do at least any one of the following to make him/her eligible to appear for final examination:

- a. Poster Presentation at a National/Zonal/State conference of his/her Speciality;
- b. Podium presentation at a National/Zonal/State conference of his/her speciality;
- c. Have one research paper published/accepted for publication in journal of his/her speciality as first author.

7. As per PGMER-2023, the criteria for evaluation of Super Speciality Courses:

The candidate shall secure not less than 50% marks in each head of passing which shall include

- a) Theory – aggregate 50% (In addition, in each Theory paper a candidate has to secure minimum of 40%)
- b) Practical/Clinical and Viva voce – aggregate 50%
- c) Practical/Clinical marks -300 & Viva Voce marks-100. Passing minimum for Practical / Clinical including Viva voce - 200/400.

- d) If any candidate fails even under one head, he/she has to re-appear for both Theory and Practical/Clinical & Viva voce examinations.
- e) Five percent marks of total marks of Clinical/Practical + Viva Voce marks (i.e.20 marks) will be of dissertation/thesis and it will be part of clinical/practical examination marks. External examiner outside the state will evaluate dissertation/thesis and take viva voce on it and marks will be given on quality of dissertation / thesis and performance on its viva voce.
- f) No grace mark is permitted in Super Speciality examination either for theory or for practical.

8. The University is implementing Digital Valuation in Super Specialty exams from July, 2019 onwards.

In view of introduction of Digital Valuation in Super Specialty exams. A single 68 pages OMR answer book with 64 writable pages will be issued to the candidates appearing for March, 2025 examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer book of 64 writable pages only.

Further it is to inform that the Digital (ONLINE) Valuation will be done with 4 examiners i.e., two internal and two external examiners as per the Orders of the Hon'ble High Court of Andhra Pradesh & Telangana in WP.No.24394 of 2017 and Other Batch Cases in PG Degree/Diploma Courses. The same was implemented in Super Specialty from July, 2019 Examinations.

IV. "The Principals of Medical Colleges are informed to upload the details of the students who are eligible for appearing for Super Speciality Examinations, March, 2025 in MEDHAS Portal i.e., http://drntruhs.nic.in/medhas_institution on or before 25.02.2025 for processing for issue of E-Hall Tickets."

V. The Principals are advised to collect and remit the Examinations fee through online payment mode on the university website before 24.02.2025 and send the same to the University along with all exam material (student details, fee payment transaction receipts, attendance statement, Principal signed printout copy of data freeze on the portal etc.) to reach in the university office by 25.02.2025.

INSTRUCTIONS TO THE PRINCIPALS: -

1. The Principals are informed to verify the eligibility of the students before submitting the data on the Portal.
2. If any ineligible student details furnished on the Medhas Portal, the Principal is solely held responsible for that.

The following copies of certificates shall be enclosed by the candidates along with the student data printed format.

- a) Print copy of uploaded student data.
- b) Dissertation submission certificate.
- c) Two Testimonials from any two Lecturers of the college concerned.
- d) Attendance Certificate from the Principal
- e) Copy of PG Original Degree (Attested Xerox copy only).
- f) A copy of Poster Presentation and research paper published.
- g) Certificate of Completion of Course in Research Methodology.

Unless these certificates are enclosed with the printed student data, the applicant will not be considered and there will not be any further correspondence in this regard.

The referred candidates have to enclose a copy of their previous Exam's Hall Ticket and also copies of their MBBS and PG Degree permanent certificates once again without fail.

Details of Practical answer books and temporary advance required are to be furnished for conducting theory/practical exams. **It must be noted that if the previously sanctioned temporary advance was not settled, no fresh Advance shall be sanctioned.**

Further it is to inform that as per the Judgment dated 04.11.2022 in Civil Appeal No 8037/2022 which Civil Appeal No. 8038/2022 of Hon'ble Supreme Court of India, New Delhi there is no provision for revaluation of answer scripts and the procedure adopted by the University in digital evaluation of answer scripts is upheld by the Apex Court.
