The Notification is issued for registration of candidates to appear for Medical PG Degree (MD/MS)/One Year Exemption and Medical PG Diploma theory examinations scheduled from **28.12.2024.** 

#### The eligibility criteria to appear for the PG exams are:-

- a) The PG Degree students who are admitted into Medical Colleges of Andhra Pradesh, whose admission are approved by the University during the academic year 2021-22 and who have completed three years of study period (36 months) including period of examinations are eligible to appear for the ensuing examinations. The students should put 80% Attendance of working days i.e., 751 days of 939 days for three years course (By 31.01.2025). However, period of training will be extended by the same number of days for which maternity /paternity/ any other leave have been availed in three years. The Principal concerned should submit study period completion certificate of the students
- b) The PG Diploma students who are admitted into Medical Colleges of Andhra Pradesh, whose admission are approved by the University during the academic year 2022-23 and who have completed two years of study period (24 months) including period of examinations are eligible to appear for the ensuing examinations. The candidates admitted in P.G Degree with one year exemption (those who have completed P.G Diploma course) for the academic year 2022-23 are also eligible to write the examinations. The students should put 80% Attendance of working days i.e., 501 days of 730 days for two years course (By 31.01.2025). However, period of training will be extended by the same number of days for which maternity/paternity/any other leave have been availed in two years.

The Principal concerned should submit study period completion certificate of the students

- c) The result of those students who didn't complete study period by exams will be announced after receipt of study period completion certificate from the Principal.
- d) The attendance certificate in respect of each candidate duly signed by the HOD and counter-signed by the Principal indicating the Academic Year / Batch of Admission, Date of Admission (Date of Joining), Details of leaves availed, Total number of leave days availed, Year-wise percentage of attendance, Date of completion of study period must be furnished in the prescribed standard proforma along with the filled-in ICR Forms. A model copy of the attendance certificate is enclosed herewith. No other format is to be used.
- e) PG Degree/Diploma students who have failed in the previously held exams are also eligible to appear for these exams.
- f) Dissertations of PG Degree Students should be approved by two external examiners and to get eligibility to appear for examinations. Hall Tickets will not be issued to those students whose dissertations are not approved by the external examiners. The student cannot be prevented from appearing in the examination if he has not obtained the approval of dissertation/thesis from the HOD.
- g) Thesis submission certificate is also to be enclosed. The candidates of PG Degree Examination must submit two testimonial certificates duly issued by two Professors, separately, in the prescribed standard proforma duly enclosed.
- h) As per NMC Post Graduate Medical Education Regulations, 2023, Under 5.2 (x):

A post-graduate student of degree course in broad speciality will do at least any one of the following to make him/her eligible to appear in his/her final examination:

- a. Poster Presentation at a National/Zonal/State conference of his/her Speciality;
- b. Podium presentation at a National/Zonal/State conference of his/her speciality;

- c. Have one research paper published/accepted for publication in journal of his/her speciality as first author.
- i) Completion of Online Course in **Research Methodology** is mandatory requirement to be eligible to appear for the final examination of the respective post graduation course and the candidates should submit Online Course completion certificate in Research Methodology
- j) All Postgraduate students shall complete course in **Ethics and** students should submit the course completion certificate. No post graduate student shall permit to appear the examination without the certificate.
- k) All Postgraduate students shall complete a course in Basic Cardiac Life Support (BCLS) and Advanced Cardiac Life Support (ACLS) and students submit the said courses completion certificate. No post graduate student shall permit to appear the examination without the certificate.
- l) Satisfactory completion of the District Residency Programme shall be an essential condition before the candidate is allowed to appear in the final examination of the respective post-graduate course.
- m) As per NMC Regulations (MCI) the minimum pass marks in theory is as follows:
- > 40% marks in each paper separately i.e., 40/100
- ➤ 50% marks cumulatively in all the four papers for degree exam and three papers in diploma exam i.e., Degree Exam 200/400 Diploma Exam 150/300.
- Degree Practical/Clinical marks 300 & Viva Voce marks 100 passing minimum for Practical / Clinical including Viva voce 200/400 and Diploma Practical/Clinical marks 200 & Viva Voce marks 100 passing minimum for Practical / Clinical including Viva voce 150/300
- Five percent of marks of total marks of Clinical/Practical and Viva Voce marks (20 marks) will be of dissertation/thesis and it will be part of clinical/practical examination marks. External examiner outside the state will evaluate dissertation/thesis and take viva voce on it and marks will be given on quality of dissertation/thesis and performance on its viva voce.
- > No grace mark is permitted in post-graduate examination either in theory or for practical.

n) In view of Digital Valuation of PG Degree/Diploma answer scripts a single 68 pages OMR answer book with 64 writable pages will be issued to the candidates appearing for December, 2024 examinations and no additional answer books will be issued to the candidates. The candidates should answer all the questions in the single answer book of 64 writable pages only

Further it is to inform that the Digital (ONLINE) Valuation will be done with one internal and one external examiners as per the Orders of the Hon'ble High Court of Andhra Pradesh in WP.No.15499 of 2023 and as per the EC resolution dated 18.07.2023. Hence, the same should be circulated to the Students and Staff and also to display in the notice boards of colleges & hospitals concerned.

Therefore, the Principals are advised to collect and remit the Examinations fee through online payment mode at <a href="https://drysr.uhsap.in/epay/by 07.11.2024">https://drysr.uhsap.in/epay/by 07.11.2024</a> and send the same to the University along with exam material (student details, fee, attendance statement, freezed copy etc.) and printout of data which is uploaded in Medhas Portal to reach by 08.11.2024.

#### **INSTURCTIONS TO THE PRINCIPALS:**

- 1. The Principals are informed to verify the eligibility of the students before submitting the data on the Portal.
- 2. If any ineligible student details furnished on the Medhas Portal, the Principal is solely held responsible for that.

Unless these certificates are enclosed with the application, the application will not be considered and there will not be any further correspondence with the candidate.

Necessary details of Practical answer books required and the amount of Temporary advance required for conducting the Examination are to be furnished by combining the requirement for PG Degree, PG Diploma Theory / Practical / Clinicals / Viva Exams. It must be noted that if the previously sanctioned advance is not yet been settled, no fresh sanction of temporary advance shall be accorded. Further no stationery shall be sent without requisition from your end.

Further it is to inform that as per the Judgment dated 04.11.2022 in Civil Appeal No 8037/2022 which Civil Appeal No. 8038/2022 of Hon'ble Supreme Court of India, New Delhi. There is no provision for revaluation of answer scripts and the procedure adopted by the University in digital evaluation of answer scripts is upheld by the Apex Court.
