University of Health Sciences Act, 1986 was published in the extraordinary issue of the Andhra Pradesh Gazette No.12 Part-IV-B, dt.01.08.2024, in which the Government has decided to restore the original name of Dr. NTR University of Health Sciences, Vijayawada.

The amendment of Act 6 of 1986 is as follows:



ACT No. 12 of 2024

AN ACT FURTHER TO AMEND THE DR. Y.S.R. UNIVERSITY OF HEALTH SCIENCES ACT, 1986.

Be it enacted by the Legislature of the State of Andhra, Pradesh in the Seventy-fifth year of the Republic of India, as follows:

- (1) This Act may be called the Dr. Y.S.R. University of Health Sciences. Secret title and (Amendment) Act, 2024.

## the state of the s A STATEMENT OF OBJECTS AND REASONS

Dr. Nandamuri Taraka Rama Rao, Former Chief Minister of Andhra Pradesh had a great vision of improving quality of medical education and health care for the benefit of people of Andhra Pradesh. He had visualized the need for establishing a dedicated University exclusively taking care of Medical, Dental, Nursing and Allied health educational institutions. In order to realize the objective, he was instrumental in establishing the University of Health Sciences through Act No. 6 of 1986. In addition, he has established the University with headquarters at Vijayawada which had played a key role in development of Medical Education in the present state of Andhra Pracesh.

This is the first University in the entire country dedicated towards medical education and health services. Recognizing his vision and contribution to the development of holistic medical education including all the health services, the government has amended the Act and named as Dr. N.T.R. University of Health Sciences by Act No.4 of 1998 and 16 of 2006. Dr. N.T.R. University of Health Sciences over a period of time has immensely contributed for the development of medical education in Andhra Pradesh. Subsequently, the government had amended the Act and renamed as Dr. Y.S.R. University of Health Sciences vide Act No. 19 of 2022.

Changing the name of the University as Dr. Y.S.R. University of Health Sciences created lot of issues for the students going for higher education for different countries.

In acknowledgment of the vision and yeoman services of Dr. Nandamuri Taraka Rama Rao, former Chief Minister of Andhra Pradesh, the government has decided to restore the original name of Dr. N.T.R. University of Health Sciences, Vijayawada.
