ORDER:

In the G.O 1st read above, consequent upon completion of the ten-year period stipulated under Section 95 of the Andhra Pradesh Reorganization Act, 2014, Government issued orders for amendment to the Andhra Pradesh Medical Colleges (Admission into Post Graduate Medical Courses) Rules, 1997 to avoid legal complications and to protect the interests of A.P. students for the academic year 2025-26, until fresh/modified Presidential Order is issued.

2. In the e-file 2nd read above, the Vice Chancellor, Dr. NTR University of Health Sciences, has reported that the Government, have earlier notified certain amendments by excluding O.U area (Telangana) with regard to Local Areas, Local Candidates vide G.O.Ms.No.83, HM&FW (C1) Dept., dt.23.07.2025 for the Academic Year 2025-26. He has therefore, requested the Government., to issue necessary clarification on implementation of G.O.Ms.No.83, HM&FW (C1) Dept., dt.23.07.2025 for the Academic Year 2026-27.

3. Government, after careful examination of the matter, hereby order to continue the interim arrangements notified vide G.O.Ms.No.83, HM&FW (C1) Department, dated 23.07.2025 for the Academic Year 2026-27 also, to avoid legal and administrative complications in the admission process and to protect the interests of A.P. students until issuance of a fresh/modified Presidential (Regulation of Admissions) Order for the State.

4. The Registrar, Dr.NTR University of Health Sciences, Vijayawada, and the Director of Medical Education, Andhra Pradesh, Vijayawada, shall take necessary action in the matter accordingly.
