ORDER:

In the G.O 1st read above, the Government issued orders continuing Siddhartha Medical College, Vijayawada, as a State-wide Educational Institution duly excluding O.U-Telangana area, as a temporary stop-gap arrangement for the academic year 2025-26 subject to the provisions of the new A.P. Educational Institutions (Regulation of Admissions) Order, as and when finalized and also subject to any court direction, in order to protect the interests of students of Andhra Pradesh and for their benefit.

2. In the e-file 2nd read above, the VC, Dr. NTRUHS, has reported that the orders issued in the G.O 1st read above specifically provides that the interim arrangement was only a temporary stop-gap measure for the academic year 2025-26, subject to the provisions of the new A.P. Educational Institutions (Regulation of Admissions) Order, as and when finalized and also subject to any court direction. The said arrangement was accordingly implemented for admissions during the academic year 2025-26. The VC, Dr. NTRUHS, has, therefore, requested the Government to issue clarification in this regard.

3. Government, after careful examination of the matter, hereby order to continue the interim arrangements issued in G.O.Rt.No.475, HM&FW (C1) Dept., dated 22.07.2025 in respect of Siddhartha Medical College, Vijayawada, for the academic year 2026-27 also, to avoid legal and administrative complications in the admission process and to protect the interests of A.P. students until issuance of a fresh/modified Presidential (Regulation of Admissions) Order for the State.
