ORDER:

Section-95 of the Andhra Pradesh Reorganization Act, 2014 (No. 6 of 2014) states that the existing admission quotas in all government and private institutions, whether aided or unaided, for higher and technical education, as governed by Article 371-D of the Constitution, shall continue as such for a period of ten years from the appointed day of bifurcation of Andhra Pradesh during which the existing common admission process shall continue.

- 2. Since the ten-year period of the Common Admission Process concluded on June 2, 2024, in the G.O.3rd read above, Government have issued orders to continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution by excluding the 36% of seats reserved and allocated to local candidates from the Osmania or Kakatiya Univeristy Local Areas (Telangana Area) under the 1974 Order. These seats shall be exclusively allocated to candidates from the state of Andhra Pradesh to comply with the requirements of Paragraph 6 of the 1974 Order read with Article 371 D of the Constitution of India. The unreserved 36% seats shall be distributed among the local candidates relating to both Andhra and Sri Venkateswara University Local Areas and can be filled by merit duly implementing the statutory reservations as applicable, to protect the interests of the students of Andhra Pradesh, until a fresh/modified Order is obtained from the Hon'ble President of India at the earliest opportunity.
- 3. In the e.file 4th read above, the Registrar, Dr.NTR University of Health Sciences, Vijayawada has reported that recently, the Higher Education (EC) Department has made certain amendments that admissions to 85% of available seats in state-wide institutions under their control shall be reserved in favour of local candidates of Andhra University and Sri Venkateswara University regions in the ratio of 65.62 and 34.38 respectively. The rest of 15% of the seats shall be unreserved. To maintain uniform admission policy for all professional courses, the Registrar, Dr.NTR University of Health Sciences, Vijayawada has proposed certain amendments to the orders issued in the G.O 3rd read above, as a temporary measure, until fresh /modified Presidential Order is issued.
- 4. In order to protect the interest of students of Andhra Pradesh and for their benefit and also to avoid the legal complications in admission process, Government have decided to amend the orders issued in the $G.O.3^{rd}$ read above. These amendments as a temporary, stop-gap arrangement only for the academic year 2025-26 subject to the provisions of the new A.P. Educational Institutions

(Regulation of Admissions) Order, as & when finalised and also subject to any court directions. Necessary steps are being taken by the concerned Department to make amendments to A.P. Educational Institutions (Regulation of admissions) Order, 1974 immediately. After careful examination of the matter, Government hereby issue the following amendment to para (5) of G.O.Rt.No.513, HM&FW(C1) Dept., Dt.08.08.2024:

For

To continue Siddhartha Medical College, Vijayawada as a State wide Educational Institution by excluding the 36% of seats reserved and allocated to local candidates from the Osmania or Kakatiya University Local Areas (Telangana Area) under the 1974 Order. These seats shall be exclusively allocated to candidates from the state of Andhra Pradesh to comply with the requirements of Paragraph 6 of the 1974 Order read with Article 371 D of the Constitution of India. The 36% seats shall be distributed among the local candidates relating to both Andhra and Sri Venkateswara University Local Areas and can be filled by merit duly implementing the statutory reservations as applicable, to protect the interests of the students of Andhra Pradesh, until a fresh/modified Order is obtained from the Hon'ble President of India at the earliest opportunity.

Read as

To continue Siddhartha Medical College, Vijayawada as a State-wide Educational Institution and admissions to 85% of the available seats (after deducting All India Quota seats) shall be divided between local candidates of Andhra University and Sri Venkateswara University regions in the ratio of 65.62% and 34.38%, with the remaining 15% treated as unreserved.

The definition of local candidates and eligibility in respect of 85% local seats and 15% Unreserved seats shall be as per respective admission rules of Undergraduate Medical and Postgraduate Medical courses applicable to Government Professional Institutions.

5. The Registrar, Dr.N.T.R University of Health Sciences shall take action accordingly.
