ORDER:

The Government have framed rules called "the Andhra Pradesh Medical Colleges (Admission into P.G. Medical Courses) Rules, 1997" for admission into P.G. Medical Courses in the State vide reference 1st read above and as amended subsequently from time to time vide references 2nd to 9th cited. Based on the recommendations of the Committee vide reference 11th read above, the Government have amended the Rules in respect of in-service reservation quota vide G.O.Ms.No.85, Health Medical & Family Welfare (C1) Department, dated.20.07.2024.

- 2. The Government therefore have reviewed the matter in consultation with the Director, Public Health & Family Welfare, A.P., and keeping in view of the representations of AP PHCs Doctors Association. Based on their request and considering the difficulties represented by them in drastic reduction of availability of clinical P.G seats to in-service doctors, as one time measure, the Government hereby decide to enhance percentage of in-service P.G Seats reservation by amending the in-service rules issued in G.O.Ms.No.85, Health Medical & Family Welfare(C1)Department,dated.20.07.2024.
- 3. Accordingly, the following Notification will be published in the Andhra Pradesh Gazette in the extraordinary issue dated.01.10.2024:

NOTIFICATION

In exercise of the powers conferred by Section 3 read with sub-section (1) of Section 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation fee) Act, 1983 (A.P. Act.No.5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Medical Colleges (Admission into P.G. Medical Courses) Rules, 1997 issued in G.O.Ms.No.260, HM&FW (E2) Dept., dated 10.07.1997 and as amended subsequently in G.O.Ms.No.85, HM&FW (C1) Dept., dt.20.07.2024.

AMENDMENTS

1. In the said rules,

(i). for sub-rule 2 of Rule (3), except the existing items (i) to (vi) under NOTE thereon, the following para shall be substituted, namely: -

For	Substituted as
Out of 50% of seats in State Government Quota, 15% of clinical seats in General Medicine, General Surgery, Gynecology, Pediatrics, Anesthesia and Emergency Medicine specialties and 30% in nonclinical specialty seats shall be allocated to inservice candidates serving in Government Health Institutions in the State of Andhra Pradesh for the academic year 2024-2025. From the academic year 2025-2026 on-wards, specialty wise requirement will be notified by the Government to the University on annual basis, subject to a maximum of 15% seats in Clinical and 30% seats in non-clinical specialties out of 50% of seats in State Government Quota.	Clinical Seats in all specialties and 30% in Non-clinical Specialty seats shall be allocated to inservice candidates serving in Government Health Institutions in the State of Andhra Pradesh for the academic year 2024-2025 and it shall be reviewed year-to-year basis based on the requirement of the Government in due consultation with the stakeholders.

- (ii). in Rule 11, in sub rule (xii),
- (a) . for the item (b) the following shall be substituted namely, -

For	Substituted as
Candidates who joined in Government Service with P.G Diploma shall be allowed to study P.G Medical Degree in the same specialty only on deputation for a period of two (2) years i.e., 24 months.

(b). for the item (h) the following shall be substituted, namely: -

For	Substituted as
Degree either prior to entry or after entry into Government service, shall not be eligible for admission into any other Post Graduate Degree.	candidates who obtained P.G Degree prior to entry into Government service will be allowed for doing in-service P.G Degree at their own cost.
